OF THE FIRST INTERNATIONAL CONTEST FOR PIANISTS AND STRINGED INSTRUMENTS

"SONORO BALTIC" 2023



I. AIMS AND OBJECTIVES

1. To create favourable conditions for students to play music, to develop their artistic taste by revealing the uniqueness of instruments.

2. To enrich the performing experience and the joy of playing music, to discover and encourage artistic self-expression, creativity and mastery.

3. To promote cooperation between music and art school teachers in the country and abroad, and to provide opportunities for sharing professional experience.

II. PLACE AND TIME OF THE CONTEST

4. The Music Contest auditions will take place **on 24 November**. The auditions will take place at the Ukmerge School of Art (Vienuolyno str. 7, Ukmerge).

5. The times of rehearsals, the start of the contest and the timetable will be announced on the website of the Ukmerge School of Art at www.meno.ukmerge.lm.lt , 10 days before the contest.

III. PARTICIPANTS OF THE CONTEST

6. The First International Piano and String Instrument Contest "SONORO BALTIC" 2023 is open to young soloists from Lithuanian and foreign non-formal music and art schools playing the piano, violin and cello.

IV. CONTEST PROCEDURE

- 7. Participants in the Piano and String Instrument Contest perform a freely chosen programme.
- 8. The programme is performed by heart.
- 9. The Jury shall have the right to terminate a participant's performance if he/she exceeds the time limit.
- 10. All groups will perform in one round.
- 11. No changes can be made to the programme of the contest as presented in the application.

12. The performances of the participants are judged by a Jury. The members of the Jury will be announced at the opening of the Contest and their judgements are final and cannot be appealed.
